

Summary of the changes to the ORC Rules and Regulations as approved at the **ORC Annual General Meeting** held on 6 November 2022 in Montecatini, Italy

# **VPP – Velocity Prediction Program**

- Hydrodynamics
  - The new residuary resistance model is implemented as a combination of the 2022 formulation and the new model based on the neural network force model.
  - Foiling and semi-foiling force models are now completely incorporated into the VPP calculations.
- Aerodynamics
  - There is an updated de-powering scheme with removal of default righting moment.
  - Sail coefficients are updated for headsails set flying.

### **IMS – International Measurement System**

- The description of the official measurer is clarified in *Rule A7.3* following the ERS definition.
- The definition of "permanently fixed" for internal ballast is clarified in *Rule B4.1(a)*.
- The LOA definition is clarified in *Rule B6.2*.
- A new definition of the codes defining appendages in full extended and fully retracted positions is included in *Rule C1*.
- CBDA measurement defining the vertical movement of the center of gravity of the centerboard or drop keel is added in *Rule C2.2*.
- Heeling angles required for inclining tests are simplified requiring the angle (on one side) of 2 4 degrees for boats with LOA < 24.0 m and 1 4 degrees for boats with LOA ≥ 24.0 m in *Rule E2.8*.
- The possibility to measure rotating masts on monohulls is added in *Rule F1.1*.
- The sail measurement stamp is updated to include the ORC logo in *Rule G8.1*.
- The possibility to accept World Sailing In-House Certification of sails is added in *Rule G8.2*.

## **ORC Rating Systems**

- Default righting moment is removed from *Rule 107.4* and is replaced with an estimated righting moment that is used where righting moment is not measured or is obtained from another source.
- Increase of the mainsail rated area when there is a rotating mast is defined in new *Rule 109.4*.
- CDL limits in *Rule 206.1* are updated following VPP updates for 2023.
- Maximum number of mainsails allowed aboard while racing is increased from 1 to 2 in *Rule 206.1*.

- Maximum number of spinnakers allowed aboard for boats with CDL of 9.861 11.961 is increased from 4 to 5 in *Rule 206.1*.
- New *Rule 301.6* clarifies that a boat shall be scored according to her own valid certificate.

### **ORC Sportboat Class Rules**

• CEXT factor for boats that do not comply with OSR 3.14 and have no trapezes is changed from 0.5 to 0.25.

### **Green Book**

- Requirement for providing a dedicated mooring place with water and electricity for each entry, except when boats are moored on buoys, is added in *Championship Rule 3.1(c)*.
- Medals to be awarded to each crew member in the top three places in overall results in each class are added in *Championship Rule 4.12*.
- New CDL limits for Class definitions in ORC Championships based on the 2023 VPP are as follows:

• The Standard Notice of Race and Standard Sailing Instructions are updated with usual housekeeping changes based on experience from 2022 championship events.
