INVITATION

The Brazilian 420 Class Association invites you and your crew to the South American Championship 2005.

1.- ORGANIZING AUTHORITY

The organizing authority for the regatta shall be The Clube dos Jangadeiros together with the Brazilian International 420 Class Association

2.- VENUE

The race area will be the Guaiba Lake in Porto Alegre, state of Rio Grande do Sul. Clube dos Jangadeiros will be the headquarters for the event. The Regatta Organizing Committee is comprised of members of the Club and the Brazilian International 420 Class Association. The regatta dates are from April 11th through April 15th, 2006.

3.- RULES

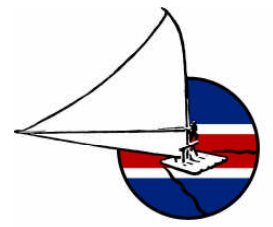
The Championship will be governed by:

- 2005 – 2008 ISAF Racing Rules of Sailing (R.R.S.)
- The rules of the International 420 Class Association.
- Appendix “N” of the R.R.S.
- Prescriptions of the Brazilian National Authority (FBVM)

4. -ADVERTISING

The regatta will be classified as a Category C Event in accordance with Appendix 1 of the RRS.

Competing boats may be required to display advertising of the Event Sponsor, on each side of the boat, on the forward 25% of the hull.

5. - ELIGIBILITY

The South American Championship is only open to International 420 dinghies. Competitors must comply with R.R.S. Appendix 2, Section II requirements.

6. - ENTRIES

A completed entry form and fee of U\$ 45 per boat must be received by the organizing authority on, or before April 13th, 2006.

7. - SCHEDULE OF EVENTS

Sunday, 16th, will be used as a spare day if necessary to achieve the number of four races.

9. - MEASUREMENT AND INSPECTION

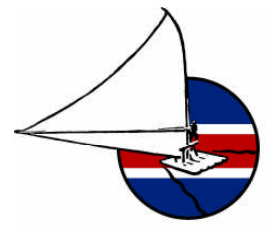
Measurement and inspection will be carried out on each yacht before its registration is complete. All competitors will be subject to random inspection at any time during the regatta by members of measurement committee.

10. - SAILING INSTRUCTIONS

A printed copy of the S.I. for the championship will be available upon registration at the Club.

11. - RACES

Nine races are scheduled. A minimum of 4 races shall be completed without dismiss, to constitute the South – American Championship. There will be one dismiss (throw-out) after five races are completed.
